Cancellation of all or part of the applied exhibition space will not be accepted. However, if the notice of cancellation request is submitted as a written notice and the reason of cancellation is deemed unavoidable, the cancellation will only be accepted upon the payment of the following charge:

- If the exhibitor notifies the organiser of his cancellation within three months of the start date of the event, he is liable for the total participation fee.

- In case of cancellation prior to the three months period, making the organiser be able to resell the stand without loss, the payment to be made by the exhibitor will be reduced to a handling fee of US\$500 irrespective of the exhibitor's full liability for additional costs, catalogue fees, etc.

7. General terms and conditions

The exhibitor agrees to follow this Specific terms & conditions, rules and regulations issued by the organiser. The organiser may add or amend regulations for smooth operations of the fair by written notice or the exhibitor manual.

8. Booth allocation

Exhibitor booth location will be allocated according to the floor space, product criteria, the order of application received and other reasonable standards. Change of booth location is not allowed once it has been assigned and the exhibitor informed.

Exhibitors shall not rent, lend or transfer all or any part of the booth space allocated to them; shall not exchange booths with other exhibitors. If this provision is violated, the organiser may dismiss the exhibitors from the show.
